4. **CASUAL VACANCY:**  
Following the resignation of Christine Misson the Borough Council were advised in accordance with regulations and a notice of casual vacancy posted. The Borough Council have advised that as there have not been requests from ten electors there will be no need for an election and that the Parish Council are to co-opt a new member as soon as practicable.

6. **TRANSPARENCY CODE:**  
**REPORT:** Following the introduction of the Local Audit and Accountability Act 2014 earlier this year the Council authorised the Clerk to undertake additional hours of work to ensure that the required information was made available on the Parish Council website.

The National Association of Local Councils lobbied for the provision of funds to be made available to Parish Councils to cover the increased costs for the financial year 2015/16. These funds have now been made available.

The Parish Council is now able to submit a grant application to cover a proportion of the costs already incurred and an allowance for the remainder of the financial year.

8. **PLANNING MATTERS**  
**15/00856/AS Land at Pound Lane, Magpie Hall Road, Bond Lane and, Ashford Road, Kingsnorth.**  
Proposal: Outline application for a mixed use development comprising:- up to 750 dwellings in a mix of size, type and tenure. –up to 210 sq. m (gross internal floor space) of A1 – A5 uses, but with no individual units greater than 150 sq. m – up to 180 sq. m (gross internal floor space) of community/leisure uses of Classes D1 and D2.- 1 form entry primary school. – provision of local recycling facilities.- provision of areas of formal and informal open space. –installation of utilities infrastructure to serve the development, including flood attenuation, surface water attenuation, water supply, waste water facilities, gas supply, electricity

supply (including sub-station, telecommunications infrastructure and renewal energy). – transport infrastructure including a new access roundabout in the vicinity of the Ashford Road/Magpie Hall Road/Steeds Lane junction, new priority control junctions on Ashford Road, a new distributor road through the site to provide relief to the existing Ashford Road plus an internal network of roads and junctions, footpaths and cycle routes. –new planting and landscaping both within the proposed development and on its boundaries as well as ecological enhancement/mitigation works. – associated groundworks. **\*\*SUBJECT TO AN ENVIRONMENTAL IMPACT ASSESSMENT\*\***

**15/01283/AS Drayswood, Ashford Road, Bilsington.**

Proposal: Demolition of existing shed and replacement triple garage with room space above.

**15/01317/AS Chestnut Lodge, Bonnington Road, Bilsington**

Proposal: Erection of a ground mounted 4kWh solar array.

9. **TELEPHONE BOX:**

The application to purchase the telephone box situated in front of the Village Hall has been acknowledged and the outcome of the consultancy period is awaited.

10. **BILSINGTON PARISH COUNCIL TOWARDS 2019:**

**REPORT:** Prior to the production of the budget for 2016/17 the Parish Council is asked to consider what projects it would like to undertake in the period up to 2019, the next election for the Parish Council.

When a list of projects has been compiled they need to be prioritised and an approximate budget for the project derived. This will enable the budget making process to be undertaken at the next Parish Council meeting when forward budgets will also be considered.

It should be remembered that the Council can consider grant applications as well as the precept for raising funds. In recent years the County Council and the major preceptors have been capped at a 2% rise, Parish Councils have not but this is no guarantee of the future.

11. **DEFIBRILLATOR:**

**REPORT:** The application to British Heart Foundation has been successful in that they have agreed to provide a defibrillator to the Parish Council upon receipt of a cheque for £400.00 from the Parish Council. The associated training kit has been delivered to the Chairman.

The Parish Council needs to arrange for the installation of the defibrillator after delivery and a series of training sessions as these were quoted in the grant submission.

12. **TRAFFIC SURVEY:**

**REPORT:** Borough Councillor is putting in place arrangements for a traffic survey in the neighbouring parish of Aldington and Bonnington. This is part of the Parish Council's submission in respect of the site submissions to the Ashford Borough Council Local Plan 2030. The survey is to not only gather the number of vehicles but the type and speed.

This information will be a valuable resource to local parishes in the preparation of its case for the restriction of parking and speeding. The Parish Council is being asked to consider making a contribution to the cost of this survey. It should be noted that this expenditure has not been included in the budget for 2015/16, in addition there is no specific legislation that covers traffic surveys. The Parish Council does have the benefit of being able to use the General Power of Competence to enable such a payment to be made. However, the Council is required to consider the following factors before making such a payment. A) the community will support the action. B) the Council is acting reasonably. C) the benefit of the survey to Bilsington.

1. Improvement Strategy – Local Councils:

The Improvement and Development Board (set up in 2013 by the National Association of Local Councils and the Society of Local Council Clerks) is about to start developing a National Improvement Strategy for Parish and Town Councils. The aim of the strategy is to

ensure local councils have the support and tools to make the most of current and future opportunities and that local communities are supported by strong, resilient and effective councils at all tiers of local government.

2. **Street lighting:**

Kent County Council recently secured funding to convert all of its street lights to Light Emitting Diode (LED) technology. LED's are significantly more efficient than the existing lights and LEDs are now used by KCC when they are replacing old or failed street lights.

With LEDs and a central Management System, KCC will be able to monitor their energy use, detect faults, dim lights and control the time that the lights turn on and off. As a result, KCC are now reviewing the way they provide street lighting and are seeking views via consultation on how people would prefer the street lights to operate.
